# Swish 3-on-3 Tournament Rules





- Flip Coin -- For first possession
- Check ball to start and between baskets
  - Ball must be passed in
- 1 & 2 points per basket
- Game over at 21 points
- 20 Min. max play time
- Defense calls fouls
- Court monitor has final say on all calls
- Fouls -- check ball, no shooting
- Technical foul (flagrant) language or inflicting intentional harm results in player being ejected from game
- Ball to pass behind 3 point line on change of possession
- Games played every half hour
- Tie Ball, teams alternate possession
- 3 second key rule in effect, players on honor system
- Subbing allowed on dead ball only
- Time outs -- 1 per team, per game -- 30 seconds

## Registration Pick-Up

Packets available from 4:00pm -8:00pm, July 7 or 7:00am - 8:30am, July 8. There is one packet per team. You must know your team name to obtain your packet. If you do not pick up your team packet as scheduled, the team's entry fee will be forfeited. All waivers must be signed at pickup.

# Registration Information

1. Instant Registration is available online at [www.bfswish.com](http://www.bfswish.com). You may also register with Check or Money Order and completed Registration Form via USPS Mail. Registration fees must accompany the attached entry form. Fees: \$60.00 for 3-Player Team, \$80.00 for 4-Player Team. Form must be **legibly and completely** filled out and signed by each member to signify his/her agreement with the information contained on it. If you are under 18 years of age, be sure to have your parent or guardian sign also. Teams missing signatures on the registration form will NOT be entered into the tournament. Make sure addresses are **legible and complete**, including zip codes and phone numbers. Registration forms must be postmarked by June 24. **No registrations will be accepted after June 28. REMEMBER TO BRING YOUR ID ON GAME DAY.**
2. Please give your team a name. Entries without a team name will be assigned one.
3. Each team must consist of 3-4 players. All games must start with 3 players on each team. Any number of players (3 or less), may complete a game. Entry fees are based on number of players per team. You can only play on one team during the tournament.
4. Each team will be placed in an age bracket. Brackets determine each player's opponents. There are all female, all male and co-ed divisions.

5. Age requirements for 18 and under. Age as of September 1, 2017 for placement in appropriate age bracket.
6. All games will take place on Main Street, downtown Bonners Ferry, beginning as early as 9:00am on July 8, 2017.
7. All teams registered in the tournament will play at least three games, subject to adverse weather conditions and court availability and team turn out. Saturday games will be pool play.
8. Unplayable conditions and situations may result in modification or cancellation of the event. Under these unlikely situations, each team will receive it's T-shirts and registration packet. **Under no circumstances will the entry fee be refunded.**
